The change in the representative directors and the appointment of directors is to be decided officially at the 209th Ordinary General Meeting of Shareholders scheduled to be held on June 26, 2020 and at the subsequent meeting of the Board of Directors.

Note

1. Change in the Representative Directors

(1) The reason for change

In order to bring rebirth to Suruga Bank through steady implementation of the Mid-Term Management Plan "Re:Start2025" announced in November 2019 and to accelerate reform of the corporate culture, a new organization will be established with current Representative Director & Vice President Kosuke Saga as the President. Furthermore, Mr. Kosuke Kato will be welcomed from outside as the new Representative Director & Vice President in order to incorporate more expertise from external sources into management in the endeavor to establish a new retail banking business, improve corporate value and strengthen the management structure as aimed in the Mid-Term Management Plan.

Current Representative Director and President Michio Arikuni will serve as the Director and Chairman, continuing to bear responsibility to steadily execute the existing Business Improvement Plan and to reform the corporate culture while supporting the new organization.
