Notice of the Appointment of Directors

Suruga Bank, Ltd. ("the Company") hereby announces that its Board of Directors has resolved at a meeting held today to tentatively submit the following candidates for consideration for the position of Director as part of an agenda item for the 210th Ordinary General Meeting of Shareholders, to be held on June 29, 2021.

Following administrative action taken against the Company by the Financial Services Agency in October 2018, Suruga Bank has been working to restore customer trust and strengthen governance based on the business improvement plan announced in November of the same year. As part of this effort, the Company established the Compliance System Restructuring Committee in November 2018, a committee driven by outside members. Having reached a certain point in the development of our compliance system, Suruga Bank transitioned to a system whereby it autonomously operates the Compliance Committee as of March 31, 2021.

In business performance, the Company has achieved a certain level of success in promoting sales and structural reforms in line with its Re:Start 2025 mid-term business plan, launched in FY2019, with consolidated net income of 21.4 billion yen for the fiscal year ended March 31, 2021.

In light of the above, starting in the current fiscal year, the Company's management structure has been designed to promote not only strengthening governance and compliance systems, but also rebuilding the Company's earnings base through retail banking, with an even greater sense of speed and in line with the mid-term business plan.
