1. Change of Representative Directors

(1) Reason for Change

In order to further accelerate progress of creating a new Suruga Bank and realizing our corporate philosophy through steady implementation of our "Re:Start2025 Phase 2" mid-term business plan (to be announced), intended to evolve our retail solutions business and build a sustainable revenue structure, a new organization will be established with current Representative Director & President Kosuke Saga as the Representative Director & Chairman. Furthermore, current Representative Director & Vice President Mr. Kosuke Kato will become the Representative Director & President.

In addition, in order to incorporate more outside knowledge into management, we have newly invited Yukiteru Yamamoto from outside the Bank as Outside Director to further strengthen governance.
